Rights

Code of ethics and review process

As a matter of principle, zfv only publishes original papers (technical papers) in the subject areas of geodesy, geoinformation and land management in German and English that have not already been published elsewhere. Authors must own all rights to the contents of their contributions.

All scientific papers are subject to a peer review process according to international standards. The reviews are carried out (unilaterally) anonymously by at least two independent reviewers per paper, whereby the reviewers know the authors. The editors of zfv carefully ensure that there is no conflict of interest between reviewers and authors.

General information on manuscript preparation, data formats and data transfer

- § Paper should not exceed 8 printed pages, including figures and tables. The print page can be calculated with 6,000 characters.
- § Figures and tables are normally set to column width (84 mm), if necessary they can be extended to type area width (174 mm).
- **§** Use clear file names which define function and sequence etc.
- § Word file format (.doc or .docx) including inserted tables and figures. The original files are also required separately from the illustrations (see "Illustrations/graphics" below).

- § Only in exceptional cases documents created with LaTeX 2e can be accepted. Important: Article Style, font size 10 points, use of standard commands and no redefining of them. Please make sure that formulas do not exceed a width of 84 mm. If necessary, line breaks have to be inserted at a suitable place. The original file with the extension .tex, the .ps file and a PDF file for viewing must be transferred. If special styles/packages (.styles) have been used, these must also be supplied.
- **§** Text and image files have to be submitted to the responsible editor for the subject areas "Physical Geodesy", "Geoinformation", "Engineering Geodesy" and "Land Management", contact details see below. If the assignment of a paper to one of the areas is unclear, the editor-in-chief will receive the paper.
- **\$** After evaluation/review (and revision), final acceptance and editing of the paper, the author receives his article as a PDF file by e-mail for correction. Corrections should be limited to typesetting errors, if possible. Major corrections or additions will be charged to the author.

Layout/Text design

Structure of the paper

- § (short) title of the article in English and German
- § first and last name of the author(s)
- **§** Summary (English, max. 10 lines) and Keywords (English, max. 5 terms)
- § Zusammenfassung (German, max. 10 lines) and Schlüsselwörter (German, max. 5 terms)
- § Text part hierarchically divided into sections, headings numbered decimally
- § References
- **§** Contact details:

Mandatory data: (if applicable, academic degree/title) First name Last name, e-mail address Optional information: Institution/Company/Authority, Street, Postcode + Town

Requirements for the paper

- **§** Uniform spelling for names, terms, abbreviations etc.
- § Highlighting of text passages by italics, no capital letters and no underlining
- **§** Avoid footnotes.
- **§** References to figures and tables in the text must be included, e.g.
 - ... is shown (Fig. 2). | Figure 3 shows...
 - ... is shown (Tab. 1) | Tab. 2 shows ...
- § Illustrations receive a caption and, possibly with mention of copyright. Tables receive a table heading.

References in the text

In the case of references in the text, only the surname of the author and the year are given in brackets, e.g.

§ one author: Müller (2017) describes is described (Müller 2017)

§ two authors:

Huber und Meier (2016) describe is described (Huber und Meier 2016)

§ from three authors:

Schmidt et al. (2015) describe is described (Schmidt et al. 2015)

§ several sources:

Müller (2017a, 2017b) describes is described (Müller 2017a, 2017b)

Müller (2017) and Huber and Meier (2016) describe is described (Müller 2017, Huber and Meier 2016)

References

Bibliographical references include the author's name (last name in full, first name abbreviated) year of publication in brackets. Then the title of the reference article, and other bibliographical information (e.g. name of book or journal, issue number, volume number, page numbers, place of publication, etc.). If there are several authors, they are separated by commas; all authors must be listed (do not abbreviate with "et al."). Several articles by the same author from the same year are distinguished by the addition "a", "b" etc. after the year. For example:

Tables

- § Tables are normally set to column width (84 mm), if necessary they can be extended to type area width (174 mm).
- **§** Tables must be numbered consecutively and provided with table headings.
- In the text, references to tables are obligatory to insert, e.g.: ... is shown (Tab. 1) | Tab. 2 shows ...

Formula

Formula have to be created either with MathType or with the formula editor of MS Word with formula numbering on the right margin, e.g.

$$x = \frac{a+b}{c-d} \tag{1}$$

When creating formulas, make sure that the width of the formula does not exceed 84 mm. If necessary, insert line breaks at a suitable position.

Simple formulas (e.g.: $a^2 + b^2 = c^2$) can be written consecutively in the text and possibly without using a formula editor.

Illustrations/graphics

- Make all original files available!

 As described above: In addition to the integrated images and graphics, the original files are required separately. In the case of Excel charts and PowerPoint slides, the corresponding original files should also be provided separately if possible.
- § If possible, no previous image editing by the author. No cropping to a format or size or a selected picture detail in the original file. If necessary, mark the desired detail in the manuscript or communicate it in a different form.
- File format for photos/images: .jpg, .tif, .psd, .png (--> possibly other formats after consultation with the publisher) Resolution for illustrations (photos, drawings or similar) at least 300 dpi in the final format and for line drawings at least 800 dpi (better: 1,200 dpi) in the final format.
- **§** File format for vector graphics (charts, diagrams, logos or similar): .ai, .pdf, .eps (--> possibly other formats after consultation with the publisher)
- § Use clear file names which define function and sequence etc., preferably numbered consecutively.
- § Illustrations are normally set to column width (84 mm), but can be extended up to type area width (174 mm) if necessary.
- § Illustrations must be numbered consecutively and provided with captions.
- In the text, references to illustrations (as with tables) must be inserted, e.g. ... is shown (Fig. 2). | Fig. 3 shows ...

Copies

The author generally receives two specimen copies per paper. For papers created by several authors, each author usually receives a specimen copy.

If only the mandatory information (first name, surname, email address) is mentioned in the contact details at the end of a paper, a delivery address must be provided for sending the specimen copies.
